3. The source of my personal data that is collected by the Data Controller is provided by myself and the application form constituting Annex No. 1 to the Competition Regulations provided to the Institute by the author of the thesis.

4. The Data Controller will process my personal data to:

1) organise and conduct the Competition, including possible publication on the Institute's website based on the Competition Regulations, under Article 6(1)(a) of the GDPR; and

2) fulfil the Data Controller's obligations under generally applicable legislation, including tax law, under Article 6(1)(c) of the GDPR.

5. My personal data may be made available to entities entitled to receive them under law or a contract.

6. The following categories of my personal data will be processed: first and last name with degree/title, name and address of the university, telephone, e-mail address, and signature. In the case of being awarded in the Competition, additionally: residence address (street, postal code, town), date and place of birth, PESEL/passport number, and NIP (depending on the value of the gift).

7. My personal data, if I am a winning author, will be disclosed to the Jury members after the end of the Competition.

8. My data will be processed for:

1) the purpose specified in paragraph 4.1: for 1 year after the end of the Competition, counting from the beginning of the year following the year in which the Competition was held; and

2) the purpose specified in paragraph 4.2: for 5 years from the beginning of the year following the year in which the Competition was held.

However, the Institute may extend the time that the personal data is kept by the period of the statute of limitations that may be available to data subjects.

9. I, as the data subject, have the right to:

2) restrict data processing in the cases specified under Article 18 of the GDPR;

3) data portability, under Article 20 of the GDPR, i.e. that I may receive the personal data relating to me from the Data Controller in a structured, commonly used, machine-readable format;

4) withdraw consent at any time without affecting the lawfulness of the data processing performed based on the consent I granted before its withdrawal; and

5) lodge a complaint to the President of the Office for Personal Data Protection with the President of the Office for Personal Data Protection at 2 Stawki Street, 00-193 Warsaw.

11. Providing personal data is voluntary.
